WHO MAY ATTEND: EMDR training is open to mental health professionals licensed (or certified or registered) by their jurisdiction for independent practice. The training is also open to advanced graduate students, interns, and other mental health professionals on a licensure track, with a letter of support from their supervisor. There is a maximum enrollment of six (6) participants. **NOTES:** The practicum part of the training requires processing personal material, although participants are always in charge of the level of disclosure.

Privacy Policy & Cancellation Policy

Privacy Policy:

When you enroll in a TI/CTI-affiliated training program, we add you to our e-mailing list and send out occasional e-newsletters. You may request to be omitted from this list.

We do not share your name or contact information with anyone. Exceptions:

1. The co-sponsor(s) must have this information in order to provide CE credits etc., and the information is shared in turn with the credentialing body (e.g., your state licensing board) as per their requirements.

2. For those completing our EMDR therapy training program, we provide the information to the EMDR International Association which accredits EMDR training programs and tracks who is trained in EMDR.

Cancellation Policy:

If a course is cancelled, participants will be offered a full refund, or may choose to apply their registration fee to another scheduled course.

If the participant cancels at least 30 days before the first course meeting, a full refund less a \$100 processing fee will be provided.

If the participant cancels less than 30 days before the first course meeting, 50% of the registration fee will be refunded and 100% of any other fees (e.g., for CE credits), as long as the participant's slot in the course is filled. There will be no refund of the registration fee if the slot is not filled.

Substitutions may be made (i.e., the participant may send another otherwise eligible participant in his/her place) for a \$100 processing fee.

No refund if the participant no-shows or cancels on or after the day of the first course meeting.

Participants who cancel due to medical emergencies or other special circumstances may explain these circumstances in writing (e-mail is ok) and request special consideration. In such circumstances special arrangements may be offered, at the instructor's discretion.
